

GAT CardDispensing Station F Dispensing Station for RFID Cards

Application

The GAT CardDispensing Station F (henceforth "Dispensing Station") is a compact automat used for dispensing RFID cards in leisure facilities such as swimming pools, spas, and fitness centers.

Visitors use the RFID cards for identification and access purposes in the leisure facility. The system provides maximum ease-of-use for visitors through contactless identification at access devices such as turnstiles and with electronic locker systems.

The robust housing is optically neutral and integrates seamlessly with the surrounding architecture and facility design themes. A customer-specific logo or design can be attached to the front of the dispensing station.



Functional description

Guests of the leisure facility are issued with a PIN code, which they enter into the keypad of the Dispensing Station upon visiting the facility. The facility management software verifies the request then dispenses an RFID card for the guest. The unique number of the dispensed card is sent to the management software. The Dispensing Station communicates with the facility management software via an integrated Ethernet interface.

The card serves as identification and allows the guest to access the facility and use specific services that are controlled by GANTNER devices. The practical design of the modular dispensing unit provides fast and easy access for refilling the Dispensing Station.



- 7. Power / Ethernet cabling outlets


Installation instructions

Install the Dispensing Station in a location that is convenient for guests of the facility to access. The unit must be placed on a level surface and within 2 m of mains power / Ethernet outlets. To prevent the Dispensing Station from overturning, two holes are provided in the rear of the housing that are used to fix the unit to the wall.



CAUTION! Do not use the wall mounting points to support the weight of the Dispensing Station.

- 1. Ensure the unit is placed on a level surface, against a wall, and within 2 m of power / Ethernet outlets.
- To access the mounting holes, unlock and open both doors of the Dispensing Station.
- 3. Mark out and drill the location of the rear mounting holes.



4. Attach the Dispensing Station to the wall using mounting hardware for the two mounting holes as shown in the diagram.

NOTE! Mounting hardware (screws, anchors, spacers) suitable for masonry walls is supplied with the unit. The supplied mounting hardware guarantees stability. If the supplied mounting hardware is not suitable for the wall material, source appropriate hardware from a specialized dealer.

5. Connect the Ethernet and power cabling (see "Electrical connections" on the following page).

Card refilling instructions



CAUTION! Always ensure that the mains power is switched off before opening the door of the Dispensing Station.

- 1. Unlock and open the top door of the Dispensing Station.
- 2. Remove the card magazine from the Dispensing Station.
- 3. Refill the cards into the magazine. Ensure the cards are not stuck together and are correctly aligned within the magazine. Remove any cards that are stuck together as these can lead to blockages.
- 4. After refilling the cards, replace the magazine into the Dispensing Station.




Catch spring

NOTE! Ensure the magazine completely clicks into place in the catch spring and that the card weight is inserted. Otherwise, malfunction and card damage may occur.

5. Close and lock the top door of the Dispensing Station.

Power supply and network (Ethernet)



Network

Connect the Ethernet cable to a separate port at the network switch. The recommended cabling for Ethernet connections between the Dispensing Station and the network switch is min. CAT 5 (STP) for 100 MBit.

Protective elements

The following elements protect the Dispensing Station:

- Fuse 3.15 A, T 5x20 mm, 250 VAC GANTNER Part No. 829019. Only use the original fuse supplied by GANTNER or a fuse of the same type.
- Sensor to prevent operation when the door of the unit is open.



CAUTION! Fuse replacement only by qualified personnel (see instructions in the manual).

Safety Instructions



- The installation and maintenance of this device must be performed by trained, qualified personnel.

- Safety devices must not be removed.

The device must be disconnected from the power supply prior to installation, assembly or dismantling.

Power supply

 $\ensuremath{\mathsf{AC}}$ supply (see technical data). Connect the power plug to a 230 VAC power outlet.

Cabling

The Dispensing Station is supplied with the required Ethernet and power cabling. The Ethernet cable is already terminated inside the unit.



CAUTION! Do not alter any of the existing internal electrical connections.

Connect the wires of the power cable to the "L", "N" and "PE" screw terminals of the connector box inside the unit (see diagram above).

The Ethernet/power cabling is 2 m long and exits the top-rear corner of the Dispensing Station housing. Connect the cabling to power and Ethernet outlets within the facility.

NOTE! Always connect the Ethernet cable before switching on power.
